### Raju Mandapati resignation from Board of Director position

- Board received an email from Raju Mandapati on Jan 8, 2019 to indicate his resignation as TAMA Board of Director (BoD) due to his inability to dedicate time and effort needed.
- Vinay Maddineni, Board Chairman indicated he spoke to Raju to understand the reasons and explore the possibility of him continue as BoD. But Raju decided to not to continue as BoD for the reasons indicated in his email to Board.
- Raj Chunduri, Board Secretary also spoke to Raju to understand the reasons and convince him to continue as BoD. But Raju decided not to continue as BoD for the reasons mentioned in his mail.
- Chairman Vinay moved the motion of accepting Raju's resignation and all the members present (9 of them) accepted. Harsha was not in the meeting and could not provide his decision.
- It was decided to complete his replacement sometime before next Board meeting.

### Clinic Fundraising

- Discussed about ways to raise funds for Clinic and other Board activities.
- Outgoing Board left \$1,800, which are enough to cover building rent for 3 months. Clinic needs around \$10,800 (\$900 per month) funds annually for its operations.
- Facebook "Giving Tuesday" Discussed about using Facebook matching donations like "Giving Tuesday". Facebbok matched the donations collected on Tuesday after Thanksgiving days by nonprofit organizations. This year's **Giving Tuesday** is on **December 3, 2019**. Let's mark that on the calendar's and make it count for TAMA
- Amazon Smile promotion also discussed. Need to find ways to utilize this program for TAMA.
- Kroger also provides similar opportunities for nonprofit organizations to raise funds.
- Details need to be worked out by a fundraising committee to be formed in the next meetings
