#### **Guidelines for Board Nominations:**

- 1. Candidates must be proposed and seconded by TAMA Life Members only.
- 2. Submit a scanned copy of completed nomination form via email to elections@tama.org by 9:00 PM EST, Sunday, October 12, 2025.
- 3. Nominations received after the above-mentioned deadline will be rejected.
- 4. A non-refundable fee of \$200 must be paid to TAMA by 9:00 PM EST, Sunday, October 12, 2025.
- 5. Payment should be made online via the TAMA website.
- 6. Along with the nomination form, candidates must send a copy of the payment receipt to elections@tama.org
- 7. The Election Committee will verify the nominations by contacting the proposers using the phone numbers provided.
- 8. To be eligible, candidates must have been a TAMA Life Member since 2022.
- 9. Candidates who have served two consecutive terms in the same TAMA position are not eligible to run for the same position for a third consecutive term.
- 10. If you wish to withdraw your nomination, please send a scanned copy of your withdrawal letter via email to elections@tama.org by 9:00 PM EST, Friday, October 17, 2025.

## **Guidelines for Executive Committee Nominations:**

- 1. Candidates must be proposed and seconded by TAMA Life Members only.
- 2. Submit a scanned copy of completed nomination form via email to elections@tama.org by 9:00 PM EST, Sunday, October 12, 2025.
- 3. Nominations received after the above-mentioned deadline will be rejected.
- 4. A non-refundable fee of \$100 must be paid to TAMA by 9:00 PM EST, Sunday, October 12, 2025.
- 5. Payment should be made online via the TAMA website.
- 6. Along with the nomination form, candidates must send a copy of the payment receipt to elections@tama.org
- 7. The Election Committee will verify the nominations by contacting the proposers using the phone numbers provided.
- 8. The contested position must be specified as listed in the TAMA Constitution and Bylaws.
- 9. A candidate may not contest for more than one position in the same election.
- 10. To be eligible to contest for a position in the Executive Committee, the candidate must be a TAMA Life Member by **June 30, 2024**.
- 11. Candidates who have served two consecutive terms in the same TAMA position are not eligible to run for the same position for a third consecutive term.
- 12. If you wish to withdraw your nomination, please send a scanned copy of your withdrawal letter via email to elections@tama.org by 9:00 PM EST, Friday, October 17, 2025.
- 13. To be eligible for the **President-Elect** position, a candidate must have served in the Executive Committee/Board for at least 3 years.
- 14. To be eligible for the positions of **Secretary** or **Treasurer** in the Executive Committee, a candidate must have served on the Executive Committee/Board for at least 2 years.
- 15. To be eligible for the position of **Cultural Secretary** or **Technology Secretary** in the Executive Committee, a candidate must have served in the Executive Committee/Board for at least 1 year.

## **Campaign Guidelines:**

TAMA Board has set the following guidelines for the campaign related to the 2026 Board and Executive Committee (EC) elections:

- TAMA will not share members' telephone numbers or email addresses with candidates or any other individuals.
- The Elections Committee requests that all candidates refrain from calling or emailing TAMA members to solicit votes for themselves or other candidates. Please respect the privacy of TAMA members throughout the election process.
- All candidates will have an equal opportunity to reach TAMA members and solicit votes through the TAMA newsletter, which will feature the profiles of all candidates.
